Welcome to the *30th Annual Gas Pipeline Safety Seminar* to be held in Montgomery, Alabama at the Embassy Suites Hotel. We have made arrangements to have the Ballroom for our meeting room and vendor displays. We hope that you plan to attend the seminar, which will start Tuesday morning at 8:25 a.m. on December 5, 2017, and end around 11:30 a.m. on December 7, 2017.

Tables for your display are available at \$100.00 per table for the length of the seminar and \$40.00 per day for any additional tables. If additional extension cords and power bars are required for your display, please bring them with you. The Hotel will furnish one extension cord per table set-up. **The entire area will be used for both classroom and displays. For your convenience, the area will be available for display assembly after 5:00 p.m., Monday night the 4th of December. This is an effort to ensure no disruption of the program. Vendor displays will be set up on the north side of the classroom; therefore, we must INSIST that all displays be assembled either (1) AFTER 5:00 p.m. the 4th of December (2) BEFORE the meeting starts on December 5th, or (3) during the lunch break on December 5th. ALL displays must be disassembled on Thursday afternoon after the meeting has concluded. *There will be no exceptions to allow anyone to assemble or disassemble their display during the meetings.***
